The UNCT's strategic interventions through the Cooperation Framework have been instrumental in achieving significant outcomes across nutrition, food security, economic opportunities, early childhood development, healthcare, governance, and environmental resilience. The Framework's alignment with national priorities and global strategies has facilitated impactful advancements in these areas, exemplifying the UN's commitment to inclusive and sustainable development in Timor-Leste. An instrumental shift in the operational paradigm of the UNSDCF Result Groups to function as 'Policy Think-Tanks' reflects a dynamic approach towards policy formulation, engaging a broad spectrum of stakeholders from academia, civil society, media, and the government. This evolution from reporting entities to catalytic forums for policy discourse signifies a deepened partnership aimed at addressing complex development challenges.

Efforts to combat food insecurity and malnutrition saw considerable progress, with large-scale assessments and targeted interventions bolstering agricultural productivity and nutritional awareness. Healthcare advancements were notable in enhancing COVID-19 vaccination rates

and addressing non-communicable diseases through pro-health taxes, alongside strides in disaster risk reduction and climate change adaptation. The unveiling of two pilot 'Investment Cases' in Food Security and Nutrition marks a strategic intervention towards mitigating the prevalent challenge of malnutrition, thereby accelerating progress towards the Sustainable Development Goals (SDGs). This initiative, rooted in a comprehensive 'Food Systems Transformation Analysis', exemplifies a concerted effort of the UN Resident Coordinator to forge a sustainable and inclusive development pathway in Timor-Leste. Key achievements include significant improvements in healthcare, particularly in COVID-19 response, nutrition and food security advancements, progress in early childhood education, and enhanced disaster management capabilities. The Report also highlights the concerted efforts in advocating for environmental and economic sustainability, particularly through the promotion of renewable energy sources. The transition of the UN Compound to 100% solar power not only represents a significant cost-saving initiative but also stands as a testament to our commitment to reducing carbon emissions and advocating for green energy solutions.



The report notes progress towards ASEAN membership, improving Timor-Leste's ties with neighbouring countries. However, challenges such as improving government budget use, addressing food insecurity and child malnutrition, and enhancing health and education still need attention.

The UN's Strategic Development Cooperation Framework (SDCF) for 2023 was implemented with a budget of US\$50.6 million, with an expenditure of US\$40.1 million, reflecting a high level of resource utilization towards strategic priorities. The report outlines the financial contributions and implementation efforts across various sectors, emphasizing the efficient use of resources in pursuit of the outlined strategic priorities.

This year also marked a significant step for Timor-Leste, with the government and the UN working together on a major plan for Atauro Island. Led by the Minister of State Administration and with the support of the UN, we launched a Strategic Development Plan, fuelled by a \$3 million fund. Our goal is to improve people's lives and the economy, especially through the Blue Economy, while protecting Atauro's natural beauty and wildlife.

Heading into 2024 and beyond, the UN team, led by the Resident Coordinator in Timor-Leste is set to intensify its support to align with the country's development ambitions, echoing the UN's Six Transitions for Systemic Impact across food systems, energy, digital connectivity, education, social protection, and climate change. This commitment is geared towards stimulating economic diversification, safeguarding human rights, broadening digital access, and fostering inclusivity. Our comprehensive strategy includes refining policy and regulatory frameworks in collaboration with Timor-Leste's government to support sustainable and inclusive growth. We're also focusing on developing investment-ready projects in key sectors such as renewable energy and digital infrastructure to attract both domestic and international investment. Furthermore, mobilizing financing through various partnerships and innovative funding mechanisms will play a crucial role in supporting Timor-Leste's priority sectors. Additionally, we're committed to building local capacity through targeted training and support, enhancing skills across project management, digital literacy, and environmental conservation. Through these integrated efforts, the UN aims to be a pivotal partner in Timor-Leste's journey towards sustainable development, ensuring that progress benefits all members of society.

CHAPTER 1

KEY DEVELOPMENTS IN TIMOR-LESTE

n 2023, Timor-Leste witnessed notable advancements across multiple sectors, marking strides forward despite persistent challenges. The smooth transition of power to the 9th constitutional government followed the successful parliamentary election on May 21, 2023. Under the leadership of Jose Alexander Gosmao ""Xanana"", the coalition led by CNRT and PD assumed office, ushering in a new era in the nation's political landscape and establishing the 9th Constitutional Government.

The strategic program for the upcoming five years (2023 – 2028) of the 9th Constitutional Government received unanimous approval from the National Parliament. Subsequently, in August 2023, the parliament also passed the 2023 budget adjustment. During its initial days, the government made significant headway across key sectors. The focus was on conducting a comprehensive review of existing processes, systems, and methodologies that impede economic growth and sustainable development. This involved restructuring the organisational frameworks of ministerial lines, revising the legal-administrative framework of national structures and policies, and delineating goals and priorities for the next five years.

Despite facing global economic uncertainties influenced by events such as the war in Ukraine, regional trade fragmentation and geopolitical tension, Timor-Leste continued its efforts to recover from the repercussions of the COVID-19 pandemic and devastating floods and continued El-Nino threat. The Asian Development Bank projected a 2.8% annual GDP growth for 2023, underscoring the resilience of the economy amidst challenges. However, execution rates of the 2023 Government General Budget fell below expectations, impeding private consumption and investment and highlighting the need for effective fiscal management and governance.

Social and humanitarian issues remain pressing concerns, with food security challenges exacerbated by global price increases and climate change impacts. Acute food insecurity affected nearly 22% of the population, while child malnutrition continued to claim lives at alarming rates. In response, interventions aimed at bolstering agricultural productivity and fostering resilience were prioritised, with initiatives to improve access to nutritious food and enhance maternal and child health services.



Timor-Leste made strides in healthcare, particularly in COVID-19 vaccination efforts and health-focused taxation. By the end of 2022, vaccination rates were commendable, contributing to lower case numbers and fatalities compared to neighbouring countries. Pro-health taxes on products such as tobacco and sugary beverages aimed to mitigate non-communicable diseases. Furthermore, progress was made in disaster risk reduction and climate change adaptation, with Timor-Leste actively participating in international frameworks and receiving support for strengthening disaster management capabilities.

The 9th Constitutional Government continues various strategies and programmes to support households and vulnerable populations such as the Cesta Basica programme, Bolsa da Mae programme, and cash payments aimed to alleviate socio-economic burdens, while investments in education targeted youth unemployment and

human capital development. Additionally, in its budget rectification, the new government continues to prioritise education, with a focus on improving access and quality across all levels. Investments in the education sector aimed to address high youth unemployment rates and enhance human capital development.

Timor-Leste strengthened its regional partner-ships, with significant progress toward ASEAN membership. Following the 40th and 41st ASE-AN Summit in Phnom Penh, ASEAN granted Timor-Leste observer status at high-level meetings, signalling a step closer to full membership, and enhancing regional cooperation. Thus, 2023 marked a year of transition, progress, and challenges for Timor-Leste. As the new government embarked on its endeavours to address socio-economic issues, strengthen resilience, and foster regional engagement paved the way for a brighter future for the country and its people.

CHAPTER 2

UN DEVELOPMENT **SYSTEM SUPPORT TO** NATIONAL DEVELOPMENT PRIORITIES - THROUGH THE COOPERATION **FRAMEWORK**

2.1. OVERVIEW OF COOPERATION FRAMEWORKS RESULTS

he UNCT in Timor-Leste made significant progress across its Cooperation Framework upon the three years of implementation, effectively responding to evolving national priorities, achieving notable results across various outcome areas, and aligning with UN regional and global strategies. Efforts led to substantial advancements in nutrition, food security, and agricultural productivity, impacting thousands through food security assessments and capacity-building initiatives. In economic opportunities and decent work, the UN supported social protection strategies, child welfare plans, and income generation, benefiting numerous community members and promoting gender equality. Early childhood education saw transformative progress, with thousands of children impacted through community-based preschools and educational enhancements. Additionally, the UN's focus on emergency readiness and response fortified Timor-Leste's disaster management capabilities, benefiting communities through infrastructure projects and renewable energy access. These achievements underscore the UNCT's effective response to evolving country situations, regional strategies, and global initiatives like the Spotlight initiative which significantly enhanced the support for gender-based violence survivors, improved access and quality of GBV services nationwide, effectively raising awareness and knowledge of essential recovery services. These achievements showcasing a commitment to inclusive, sustainable development aligned with the SDGs.

In 2023, Timor-Leste saw notable advancements in addressing food insecurity, markedly improving from the risks identified in the updated Common Country Analysis (CCA). The UNCT's efforts led to the production of the nation's first Integrated Food Security Phase Classification (IPC) Acute Food Insecurity analysis and an update to the 2019 Cost of the Diet analysis, significantly enhancing evidence-based advocacy and capacity building. The largest Food Security Assessment to date covered 9,488 house-holds, informing targeted interventions. These achievements demonstrate a comprehensive approach to mitigating food insecurity, leveraging local resources, and promoting nutritional education, significantly contributing to the country's resilience against food insecurity as previously outlined as the risks in the CCA.

SP1. Nutrition, Food Security, and Sustainable Agriculture

Timor-Leste made significant strides toward improving nutrition, food security, and agricultural productivity through collaborative efforts led by the UN and various stakeholders. Initiatives included the country's first IPC Acute Food Insecurity analysis, a comprehensive Food Security Assessment covering 9,488 households, and the creation of 65 nutritionally balanced school meal menus. Efforts also enhanced health and nutrition services, reaching over 85,000 people with social media campaigns on nutrition and treating 2,827 children for Severe Acute Malnutrition with a 73% cure rate. Agricultural advancements supported 7,200 households with modern farming techniques and rehabilitated irrigation canals, benefiting 650 farming households. These comprehensive actions aim to ensure equitable improvement in the lives of all Timorese, showcasing a commitment to leaving no one behind.

SP2. Sustainable Economic Opportunities and Decent Work for All

Timor-Leste advanced in creating sustainable economic opportunities, focusing on inclusivity. Key achievements included the launch of its first Social Security Portal, finalization of the Child Labour National Action Plan, and significant enhancements to the social protection framework. Notably, the Cash for Work program employed 4,128 individuals, while entrepreneurship training benefited over 743 youths. Additionally, 349 youth entrepreneurs received support across all municipalities, and the soft loan initiative enabled 8 MSMEs to secure loans. The UN's efforts in cultural preservation and economic empowerment through green agri-enterprises training for 115 rural youths and funding for 33 youth-led enterprises underscored a comprehensive approach to economic development and decent work in Timor-Leste. These achievements mark substantial steps towards Timor-Leste's goals for 2025.

SP3. Early Childhood Development and Life-long Learning Outcomes and Skills

The UN significantly advanced early childhood education in Timor-Leste, impacting 3,084 children through 96 community preschools and preparing 977 children for grade 1 with the help of 164 trained facilitators. The Southeast Asia Primary Learning Metrics field trial involved 1,714 students, enhancing learning assessment capabilities. WASH facilities improvements and ICT education enhancements, including the Timor-Leste Learning Passport Platform, were notable. Efforts for inclusive education strengthened support for children with disabilities, with significant advancements in occupational therapy training and communication support. Additionally, innovative approaches to address social stigmas and promote inclusive dialogue reached thousands, while pioneering teacher training modules for history education aimed at peacebuilding were developed. Comprehensive Sexuality Education training certified 45 trainers, supporting youth education on critical topics. Legislative advancements and policy development efforts, such as the Decree Law on teacher competencies, aligned with SEAMEO standards, marking a commitment to enhancing education quality and teacher standards in Timor-Leste.



SP4: Quality Healthcare and Well-being

Timor-Leste made strides in healthcare, notably increasing skilled birth attendants from 30% to 57% and aiming to reduce under-5 mortality. With UN support, it enhanced midwifery education and inaugurated a new BEmONC centre, improving GBV response. The National AIDS Institute's plan and UN-backed initiatives led to widespread HIV testing, reaching nearly 12,000 people. Efforts in capacity building and digital health advancements were key, alongside significant enhancements in routine immunizations, achieving a 90% coverage rate. The UN's support in critical care, capacity building, and health infrastructure, including a \$260,000 procurement for essential health commodities, marked a year of comprehensive health system strengthening in Timor-Leste.

SP5: Accountable, Inclusive and Participatory Governance and Quality Public **Services**

Timor-Leste saw remarkable progress across peacebuilding, gender equality, and human rights, highlighted by the establishment of its first National Mediation Network and Community Mobiliser Networks to combat human trafficking. Efforts to combat workplace violence led to the development of a Pocket Guide, significantly enhancing GBV support and services, reaching over 74.305 individuals. Legal advancements included the Protection of Children and Youth in Danger Law, alongside a notable increase in female voter turnout and the election of the first female President of the National Parliament. Health sector improvements featured the development of disability and gender-related indicators for the HMIS Strategic Action Plan. The year also marked the reactivation of the "Women in Leadership and Diplomacy Forum" and the development of Standard Operating Procedures for emergency protection by IOM and UNICEF, underscoring a commitment to inclusivity, safety, and resilience.

SP6: Sustainable Management of Natural Resources and Resilience to Climate Change

Timor-Leste, with the UN's support, significantly enhanced its emergency preparedness and response capabilities. Key initiatives included deploying Disaster AWARE Pro to extend early warning systems, protecting 5,200 individuals from agricultural droughts through the Anticipatory Action Protocol, and documenting over 30 first-hand accounts of natural disasters to improve future strategies. Efforts also focused on training 61,000 individuals in disaster risk management, completing 18 climate-resilient infrastructure projects, and improving renewable energy access for 7,000 rural residents. Additionally, a new Marine Protected Area was established, covering 51,000 hectares, as part of efforts to manage coastal and marine resources effectively.

he concerted efforts and pivotal achievements under outcome area 1, aimed at enhancing nutrition, food security, and agricultural productivity for all individuals in Timor-Leste, irrespective of their ability, gender, age, socio-economic status, and geographical location. With the support of the UN and other key stakeholders, has embarked on a transformative iourney to address the critical challenges of food insecurity, malnutrition, and inadequate agricultural productivity. Our overarching goal is to ensure equitable improvement in nutrition and food security, catalysing agricultural advancements that benefit every segment of the population.

During the 2023, UN have put together the efforts to achieve its commitment including contribution to the Evidence-Based Advocacy and Capacity Building have been produced the country's first-ever IPC Acute Food Insecurity analysis, updated the 2019 Cost of the Diet analysis, and conducted the largest Food Security Assessment covering 9,488 households. Designed 65 nutritionally balanced school meals menus under School Meals Program Enhancement by using locally sourced ingredients and trained 655 school feeding management teams across thirteen municipalities. Additionally, increased capacity-building efforts, training 215 government staff on fortified rice and nutrition, significantly up from the previous year and a successful social media on nutrition and health campaign reached over 85,000 people.

Some progressive initiatives have been taken by the UN on Health and Nutrition Assessments, in which Supported the assessment of food environments, focusing on HFSS foods, and institutionalised a standard training package for health workers on optimal nutrition behaviours and healthy diets. Breastfeeding Promotion Campaign have been launched a year-long national campaign, resulting in the promulgation of the National Decree Law for the regulation of marketing of breastmilk substitutes.

Additionally on the Nutrition and Health Services have been reached 2,827 children with Severe Acute Malnutrition (SAM) treatment, achieving a 73% cure rate, and supported the expansion of the Mother Support Group (MSG) network, training 120 health workers and 4,223 MSG members on infant and young child feeding. To be more contributed to the health service, water, sanitation, and hygiene (WASH) services across 13 Community Health Centers have been enhanced.

On agricultural practices, the UN in collaboration with the government has supported development of the suco plan and vision, improving food security and nutrition for 244 households. UN has also expanded Conservation Agriculture (CA), Climate Smart Agriculture (CSA), and Nutrition Sensitive Agriculture (NSA) to 10 municipalities, 84 suco, which benefited more than 7,200 households. To enhance the sustainability for the farmer, the training for 344 farmer groups was conducted for CA/CSA and NSA techniques, covering 3,800 ha of agricultural land, and rehabilitated 36 small irrigation canals, benefiting over 650 farming households and restoring 1,000 ha of paddy field. The UN has also procured 23 MT maize seeds, provided to 5,200 households as an incentive for adopting improved agricultural practices.

These collective efforts have significantly strengthened Timor-Leste's capacity in food security, nutrition, education, and social protection, showcasing a successful collaboration between international agencies, government partners, and local communities. The collaborative efforts detailed in this report underscore a significant stride towards realising our shared vision for Timor-Leste by 2025. By harnessing the strengths of each partner and focusing on inclusive, sustainable approaches, we are poised to make substantial progress in improving the lives of all Timorese, aligning with our commitment to leave no one behind.

RG1 STORY:

Food Loss and waste in Timor-Leste

In Timor-Leste, a pressing issue unfolds beyond the harvest season, capturing the essence of a struggle deeply rooted in the lifecycle of food production—food loss and waste. This narrative seeks not only to shed light on the challenges faced by the local agricultural community but also to advocate for transformative actions aimed at fortifying Timor-Leste's food security and economic stability.

The journey of agricultural products from the farm to the market is fraught with obstacles. Small-scale farmers, traders, transporters, and vendors navigate a landscape marked by inadequate post-harvest management practices. This journey, documented in a revealing video, uncovers the extent of post-harvest losses that occur, signaling a critical area of concern in the quest to bolster Timor-Leste's agricultural sector. The video's purpose transcends awareness; it is a call to action for targeted training and infrastructural enhancements to minimize these losses.

DG Odete Guterres, the National General Director of Agricultural and Irrigation under the Ministry of Agriculture and Fisheries (MAF), highlights the challenge of post-harvest losses—affecting staples like rice and grains significantly. The absence of research focused on improving supply chain management for horticultural products from production to consumption is a gap that needs urgent addressing.

Agriculture stands as the backbone of Timor-Leste's economy and the primary source of livelihood for a majority of its population. Yet, the specter of poverty looms large, with 42% of the population caught in its grip. The complexity of this challenge is compounded by inadequate capacity development, insufficient infrastructure, and rapid population growth, leading to notable food

losses. These losses, both in quantity and quality, have dire consequences—perishable products are either discarded or fed to animals, contributing to the country's food insecurity crisis.

The Food and Agriculture Organization (FAO) estimates Timor-Leste's food loss and waste at 19%, a significant figure that underlines the urgent need for intervention. With 430,000 people facing severe chronic food insecurity, the stakes could not be higher.

Personal testimonies from local farmers and retailers bring the issue closer to home. Nicolao Moniz, a horticulturist from Covalima municipality, speaks of the logistical nightmares faced during transportation, where poor road conditions lead to significant damage to produce. Baltazar Silva, a tomato retailer from Dili Municipality, echoes this sentiment, pointing out the additional challenge of inadequate storage facilities which exacerbate the problem. Andre Ventura, another horticulturist, emphasizes the absence of capacity development training in improved post-harvest practices, highlighting a widespread desire for knowledge and improvement among the farming community.

This story, woven from the realities faced by Timor-Leste's agricultural sector, serves as a stark reminder of the interconnectedness of food security, economic stability, and sustainable agricultural practices. By championing capacity building and infrastructural investment, there is a path forward to reduce food losses, strengthen the national food system, support farmers, and ensure that safe, nutritious, and affordable food is accessible to all in Timor-Leste. The narrative transcends the boundaries of Timor-Leste, resonating as a global call to action against food loss and waste, urging for collaborative efforts to secure a sustainable food future for all.

n 2023, the United Nations enhanced the Ministry of Social Solidarity and Inclusion's capacity by developing tools for effectively implementing the National Strategy of Social Protection 2021-2030. This support led to accurate cost estimates for reforms in national financing schemes like Bolsa da Mae Jerasaun Foun, the social pension, school feeding programs, and maternal and child health care expenditures. Additionally, the launch of Timor-Leste's first Social Security Portal by the National Institute of Social Security (INSS) marked a significant advancement, offering a user-friendly online platform for citizens, workers, and employers to access social security information, thereby streamlining the delivery of social protection programs.

By June 2023, Timor-Leste achieved a significant milestone in child welfare by finalizing its inaugural Child Labour National Action Plan (NAP), which was subsequently presented to the Labour Inspector General, the National Commission, and the Ministry of Coordinating Economic Affairs (MECAE). This development represents a key strategic advancement in the nation's efforts to address and mitigate child labour.

Additionally, the UN played a pivotal role in enhancing Timor-Leste's social protection frame-

work. Key achievements include the revision of national legislative provisions for improved social protection coverage, aligning them with the country's needs and ILO Convention 102 standards. A governance structure for the National Strategy of Social Protection 2021-2030 was established, including the National Council of Social Protection, an Executive Secretariat, and a Monitoring and Evaluation Technical Working Group. Further to that, legislation was enacted to create an intersectoral statistics group for social protection, tasked with key indicator calculations and the publication of Timor-Leste's first social protection statistics bulletin. Efforts also included reviewing the hazardous child labour work list decree law, preparing a legal assessment for ILO Convention No. 190 implementation, and drafting new laws against workplace violence and harassment, involving extensive consultations across six municipalities. These strategic developments mark significant progress toward strengthening social security and protecting vulnerable populations in Timor-Leste.

The UN effectively promoted income generation in Timor-Leste, focusing on young men and women through various initiatives. The Cash for Work program, aimed at rehabilitating irrigation

canals, provided employment to 4,128 community members, including significant participation from youth and women. Additionally, a job match-making scheme through internships secured full-time jobs for 70 university graduates. In the Oecusse region, the introduction of innovative farming techniques boosted the incomes of approximately 123 farmers. Furthermore, over 743 youths benefited from entrepreneurship training, acquiring skills for income generation and job creation, including structured entrepreneurship programs and green agri-enterprises training.

In 2023, the UN significantly empowered micro, small, and medium enterprises (MSMEs) in Timor-Leste, focusing on youth and women-led businesses by facilitating access to finance and seed funding. A total of 349 youth entrepreneurs across all municipalities, including Oecussi and Atauro Island, benefited from this initiative. The UN also organised promotional events like the Entrepreneurship Expo and Tais Cultural Exhibition to showcase local products. Furthermore, a soft loan initiative with BNCTL enabled 8 MS-MEs to secure loans for sustainable financial access. To foster green Agri-enterprises among the youth, the UN integrated green job initiatives into the National Youth Action Plan 2023-2027, training 115 rural youths and funding 33 youthled green enterprises. The UN efforts in cultural preservation included launching a Tais Cultural Exhibition Center and hosting a workshop on Tais Certification, promoting economic benefits for weavers and cultural heritage to younger generations.

Various supports have been provided by UN agencies to both creating sustainable economic development and promoting decent works to all. A series of entrepreneurship training, support on access to finance, and promotional events have been implemented in 2023 to generate sustainable jobs especially for young women and men. The main reflection is to promote a more integrated approach in organising the supports, for instance, by streamlining the various entrepreneurship training and channelling all trainees to financial access through various platforms, such as business competition, seed funding, and low interest loan guarantee scheme. Similar for the promotional events, thematic promotional events can be organised periodically in a more integrated manner to not only build a clear narrative of the UN but also to effectively measure the impacts. This integrated support will also help the UN to formulate concise policy recommendations for instance in MSMEs development or business enabling environment. A series of policy work in strengthening the national social security system as well as promoting decent works for all was completed in 2023. The key takeaway is to ensure the policy formulation is translated and embodied to the 'government's program and various employment support provided by the UN on the ground.

RG2 STORY:

Timor-Leste's internationally certified trainers are ready to boost women entrepreneurship in the country

The Women Entrepreneurship Development (WED) certificate are awarded to four trainers, with support from the ILO, certifying them as the ILO's Gender and Entrepreneurship Together (GET Ahead) trainer.

"This is my first time being awarded with the international scale of certificate. I am so proud. All the hard works are really paid off," said Julia B. Leite Araujo, Executive Director of the Institute for Entrepreneurship Support and Development (IADE) when receiving the Women Entrepreneurship Development (WED) certificate certifying her as the Gender and Entrepreneurship Together (GET Ahead) trainer.

She received the certificate together with three other lead trainers: Ivo Inocencio Alecrim from IADE as well as Jacinta Abu Cau Pereira and Miranda Esperito Santo from the Timor-Leste Businesswomen Association (AEMTL). The award ceremony was held on 24 October during the opening of the ILO's fair exhibition joined by graduates of the GET Ahead training presenting their businesses and products.

Julia said she undertook the Training of Trainers (ToT) of GET Ahead under the supervision of the ILO's master trainer from Uganda, David Katenderi.

"I was so excited being selected for the second ToT with the international trainer in 2022 after my first ToT in 2008. Out of 15 participants, only four were passed the training and able to move on to the next steps," said Julia.

As part of the certification process as a lead trainer, she was assigned to conduct two Training of Entrepreneurs (ToE) programmes for 36 participants in two districts, followed with business coaching programmes for three to six months. Before the ToE, she had to select the participants, asses their needs, develop a tailoring training plan and facilitate a 5-day training workshops.

"I literally have to study hard and do a lot of readings and preparations. At the same time, I also have to finish lots of assignments. However, I feel motivated, and I have to fight to reach the end of this long process of being trained as a GET Ahead trainer," she recalled.

During the training process, Julia was also in the beginning of her pregnancy. Yet, she continued to work hard providing training and assistance to the participating entrepreneurs who also included dropped out youth and female victims of violence.

Fostering entrepreneurship for better incomes and living conditions

"The main challenge is different level of understandings among participants. Due to difference in level of education, some participants need longer time to understand compared to other participants. But, at the end, 50 percent of active participants are succeeded to develop their businesses," shared Julia who is now in her third trimester of pregnancy.

A similar experience was also shared by Jacinta Abu Cau Pereira from AEMTL. As a businessperson herself, she was enthusiastic in participating at the ILO GET Ahead's ToT twice in 2021 and 2022. "The second ToT has put the emphasis on more detailed and specific business plans and prepared the participants to be a trainer," Jacinta said.

After the ToT. Jacinta also had to conduct two ToEs and individual coaching for 3 to 6 months. Not only business theory, she added, the ToEs provide practical exercises that are suitable with the reality and experience of each participant. The ToEs also discussed about digitalization and access to the banking system.

During the individual coaching, Jacinta would review the business plan and its progress. She would spend at least 3 hours to review, observe and coach the selected participants. During the coaching session, she would provide suggestions and refer the participants to find their own solutions in their training materials. "As a trainer, we should ensure that our participants or clients would be pro-active and full of initiative in finding their own solutions and to make the best use of materials that are already provided," explained Jacinta.

Both Julia and Jacinta hoped that the ToEs would help local women and other vulnerable groups to earn incomes and improve their living conditions. "I am delighted when participants realize that their businesses are the sources of employment and incomes that would help them having a better life and supporting their families," remarked Julia; meanwhile, Jacinta wished,"I hope that women would be more independent and do not have to solely depend on their husbands."

Both stated that they would continue providing ToEs through their own organizations to help those who wish to start and establish their business, especially women survivors from gender-based violence, LGBTI and people with disabilities. They also would continue promoting GET Ahead training programmes to various business associations, employers' organizations and relevant national and international organizations to ensure the sustainability of the training programme.

The ILO's support was given through the Spotlight Initiative in Timor-Leste —a joint initiative of EU-UN to eliminate violence against women and girls. This global initiative is implemented by the ILO together with four other UN agencies in Timor-Leste.

To date, the GET Ahead training programmes have reached a total of 144 women survivors, LGBTI and persons with disabilities. The GET Ahead is a gender-sensitive entrepreneurship training programme addressing some of the barriers women and other vulnerable group face in starting and running a business, including lack of entrepreneurial knowledge and skills, low confidence, and gendered norms and roles that increase the burden of household and care responsibilities.



STRATEGIC PIRORITY 3

Early Childhood Development and Life-Long Learning Outcomes and Skills

he UN embarked on a mission to transform the landscape of early childhood education in Timor-Leste under the outcome area 3, marking a year of significant progress and outreach. This has been impacting 3,084 children through 96 community-based preschools. A strategic initiative ensured 977 children are set for grade 1 in 2024, complemented by specialised training for 164 facilitators. The establishment of an Early Childhood Development Steering Committee underlines 'UN's high-level advocacy for integrated ministerial efforts in education. Expanding the School Readiness Program to 71 schools benefited 3,142 grade 1 students, and engaging 199 teachers, 226 young facilitators, 514 parents, and 751 community members in educational and community activities.

In October 2023, the Southeast Asia Primary Learning Metrics (SEA-PLM) field trial marked a significant achievement, involving 1,714 students. This initiative, supported by the UN and the Ministry of Education (MoE), aims at enhancing learning assessment capabilities. The success of the field trial was underpinned by comprehensive capacity building for MoE officials, including data management and coding training. The comprehensive review of WASH facilities in 18 schools led to the initiation of construction for improved sanitation in 8 schools, with completion expected in early 2024. A detailed assessment among 249 teachers on ICT in education highlighted key challenges and shaped the refinement of training modules, including the Timor-Leste Learning Passport Platform, where 51 teachers received specialised training.

Following the National Parliament's ratification of the Convention on the Rights of Persons with Disabilities, UN's proactive support for inclusive education led to tangible outcomes. This includes strengthening ALMA Sisters, an organisation dedicated to children with disabilities, by training 19 staff members in occupational therapy. Collaboration with a Chilean start-up facilitated the localization of the C-Board app into Tetum, enhancing communication support for children with disabilities across three institutions, involving 63 staff members. Cboard is an open source Augmentative and Alternative Communication (AAC) application created to support children and adults with speech and language impairments. Additionally, 47 facilitators and field officers were equipped with the Child Functioning Screening Tool, advancing early disability detection and educational access.



Additionally, efforts to combat social stigmas, like menstruation and disability inclusion, involved engaging educational and community groups through innovative methods, including theatre performances that reached 2,500 individuals, showcasing improved understanding on sensitive topics. The 'Back to School' campaign encouraged timely school enrollment through widespread media. Moreover, 'Girls' clubs' in 20 schools promoted inclusive dialogue, benefiting 400 students and PTA representatives, reinforcing UNICEF's leadership in education advocacy as evidenced by its re-election as Co-chair of the Local Education Group.

In 2023, UN's work in Timor-Leste marked significant progress in education reform, guided by global recommendations on education for peace, human rights, and sustainable development. Through a collaborative effort with the Ministry of Education, INFORDEPE, and Chega National Centre, UN developed pioneering teacher training modules for history education. These modules, designed for basic and secondary education levels, offer transformative pedagogies aimed at peace-building. Additionally, the UN facilitated the formation of history teacher networks, engaging over 200 educators in workshops to enhance the quality of history and peace education across the nation.

In 2023, UN Timor-Leste successfully conducted three Training of Trainers sessions in Comprehensive Sexuality Education (CSE), certifying 45 trainers. This initiative, aimed at both in-school and out-of-school settings, was led by the UN's expert team. The certified trainers are now equipped to deliver CSE, GBV, and SRH training as per the developed manuals. Additionally, UN's advocacy efforts resulted in the release of the National Action Plan for Youth, with plans to extend its reach by translating it into English and Portuguese. These initiatives address critical needs among Timor-Leste's youth, with 60.7% of the total population younger than 25 years old, 33% aged between 10 and 24, particularly given the high youth population and challenges such as unemployment around 14% and access to education for around 20,3%.

Timor-Leste advanced teacher quality and educational outcomes through the Decree Law 31/2023, defining mandatory teacher competencies in languages, scientific knowledge, pedagogy, and ethics, aligning with SEAMEO standards. This move reflects the nation's commitment to enhancing education quality through improved teacher competencies and international alignment. The UN conducted situational analysis supported Timor-Leste's educational policy development efforts, identifying a critical need for a national teacher competency framework to address inconsistencies in teaching and learning quality across regions. The report, completed in December 2023 and submitted to the Ministry of Education, underscores the impact of lacking a comprehensive framework and recommends the development of one to enhance teaching standards and competencies.



RG3 STORY:

n exciting journey through the transformative power of hands-on science education, narrated through the eyes of Antero da Costa Fernandes, a passionate Chemistry Teacher at the Secondary School of Ho Iso Lara Iso in the Liquica municipality. In a ground-breaking development that has sparked joy and pride among educators and students alike, our school's science laboratory underwent a significant rehabilitation, courtesy of UNESCO. This milestone was celebrated with a grand launch on January 19, 2023, marking the beginning of a new era in science education for us.

As educators, the support from UNESCO has been a beacon of hope, enabling us to bridge the gap between theoretical knowledge and practical application. This initiative has not only benefited secondary school students but has also extended its reach to primary levels, fostering a comprehensive understanding of science from an early age. The enthusiasm is palpable in both teachers and students, as they now have the opportunity to bring their textbook theories to life in a fully equipped laboratory. The training provided to us teachers on leveraging these new resources has further enhanced our teaching methodologies.

The highlight of our academic year was participating in the World Science Day celebrations

and competitions. Armed with our newfound laboratory prowess, our school stood out in the science competition, earning the title of the "favorite winner," a recognition bestowed upon us by esteemed figures such as the Minister of Education, the Ambassador of Japan, and other dignitaries present at the event.

But the impact of the refurbished laboratory extends beyond the confines of our school. It has become a hub of scientific exploration for the entire Liquica municipality, with teachers from neighboring schools invited to utilize the laboratory kits for their students. These kits, encompassing subjects like Biology, Mathematics, Chemistry, Geology, and Physics, are not just tools but gateways to discovery and understanding.

The most profound transformation, however, is observed in our students. The laboratory has become a crucible for curiosity and knowledge, where they realize the limitations of rote learning. Through hands-on experiments, they experience firsthand the wonders of science, leading to a deeper and more meaningful engagement with their studies. This shift from passive learning to active exploration is perhaps the most significant achievement of our collaboration with UNESCO, heralding a new chapter in the educational journey of Liquica's young minds.

espite challenges posed by national elections and leadership changes in the Ministry of Health, 2023 has seen significant progress in health and well-being, contributing to the achievement of SDG-2030 health targets. This progress is attributed to the concerted efforts of the UN, providing comprehensive support from national strategic planning to local implementation. Significant achievements include the strengthening of critical health systems, development of policies and strategies, strengthening its primary healthcare system by enhancing the availability, accessibility, and quality of health services, workforce, and facilities with the support of the United Nations and other international partners. These milestones, supported by technical assistance from the UN, are instrumental in driving forward Timor-Leste's health initiatives.

The nation broadened the scope of its essential healthcare services, incorporating a comprehensive approach to Sexual and Reproductive Health (SRH), Gender-Based Violence (GBV), HIV, and Family Planning, with the guidance and support of the UN. A key achievement in this endeavour was the notable increase in skilled birth attendants, rising from 30% to 57%, alongside a concerted effort to reduce the under-5 mortality rate from 22 to 26 over the past decade.

With UN's assistance, the Ministry of Health ensured that midwifery schools met the International Confederation of Midwives (ICM) standards for high-quality pre-service education. A significant achievement was the completion of the 13th competency based EmONC training batch, which included midwives and medical doctors from 8 different municipalities, totaling 154 healthcare providers skilled in EmONC across the country. The inauguration of a new Basic Emergency Obstetric Neonatal Care centre (BEmONC) in Atauro, along with three safe spaces within health facilities were established in Ermera, Bobonaro, and Liquica for GBV victims, further exemplifies the country's dedication to improving healthcare services and infrastructure. These complement the integrated healthcare approach provided by the community health centres in Vera Cruz and Comoro, which offer first-line support to GBV survivors.

In 2023, the National AIDS Institute (INCSIDA) launched a comprehensive 5-year National Strategic Plan (2024-2028) to align and enhance national efforts for HIV prevention, aiming to meet the ambitious targets set in the Timor-Leste National Strategic Plan for HIV, STIs, and Viral Hepatitis (2022-2026). Timorese Civil Society Organizations, with UN support, successfully delivered SRHR-HIV information, care, and support

to People Living with HIV. Concurrently, the Ministry of Health, backed by the Global Fund and UN, facilitated HIV testing for nearly 12,000 individuals, ensuring prompt referral for HIV-positive cases to ART services for treatment initiation. The culminating point of the great stride made in the area of HIV was the successful piloting of the Pre-Exposure Prophylazis (PrEP) introduced within the key population and adopted by more than 200 beneficiaries.

Through capacity-building initiatives, such as clean and safe delivery and essential newborn care training, health worker competency has been significantly enhanced, addressing the challenge of low skilled delivery rates and antenatal care engagement. The review and update of the National RMNCAH Strategy and the National Immunization Strategy, supported by the UN, alongside the expansion of digital health technologies, exemplify the ongoing commitment to strengthening Timor-Leste's health system infrastructure.

The UN significantly enhanced healthcare services by supporting critical care units in regional hospitals, establishing simulation labs for health workforce capacity building, and initiating colposcopy clinics for early cervical cancer detection and management. Further achievements include the formation of the National Codex Committee for food safety, implementation of pro-health taxation on tobacco, alcohol, and sugary drinks, and advocacy for breastfeeding promotion and non-communicable disease (NCD) risk factor reduction. Additionally, the UN has played a pivotal role in the formulation of a decree law regulating the market for breast milk substitutes, expanding tobacco cessation cen-

tres, and introducing open gyms across all municipalities to promote healthy behaviours.

Through collective support the UN achieved a 90% coverage rate for routine immunizations, 80% for the Pneumococcal Conjugate Vaccine (PCV), and 95% PCV coverage for infants under one year in each municipality. A nationwide deworming campaign in schools and a successful pre certification mission for malaria elimination further exemplify UN's commitment to improving public health. The UN has bolstered the Timor-Leste Health Information System (TLHIS), achieving over 98% monthly reporting rates from each municipality.

UN's efforts in capacity building have led to the development of the first National Training Policy, institutionalising in-service training for healthcare professionals nationwide. This includes training in Basic Emergency Care, National Basic Life Support, maternal and perinatal death reporting, and essential newborn care, among others. NCD screening and control activities have seen substantial expansion, with significant improvements in oral health, eye care, and mental health initiatives. RG-4 also supported the Department of Health Financing to implement prohealth taxes and Health Budget Execution Study. Finalisation of National health Accounts is underway, which will help in monitoring the national health expenditures for better planning and resource management in the country. Through the Third-Party Procurement (TPP) system with the UN, the Government of Timor-Leste mobilised an additional USD \$260,000 in 2023 for the procurement of family planning commodities, essential medicines, and life-saving equipment, showcasing a commitment to bolstering health infrastructure and services.

RG4 STORY:

Revitalizing Public Health in Timor-Leste: A Comprehensive Approach Amidst the Pandemic

On January 12, 2023, Timor-Leste embarked on a groundbreaking journey to fortify its public health defenses against the backdrop of the COVID-19 pandemic with the official launch of an integrated immunization campaign. This initiative, a collaboration between the World Health Organization, UNICEF, and other key partners,

epitomized a holistic approach to healthcare by amalgamating routine immunizations with COVID-19 vaccinations, and augmenting these efforts with deworming and vitamin A supplementation.

The essence of this campaign was to counter the disruptions experienced by routine health programs due to the pandemic. As COVID-19 spread, the continuity of essential immunization activities was challenged, with healthcare workers often redeployed to pandemic response duties and parents increasingly wary of exposing their children to the virus at health facilities. Amid these challenges, Timor-Leste's health authorities recognized the critical need to rejuvenate their immunization efforts, leading to the innovative integrated campaign that aimed to leave no one behind.

This ambitious campaign targeted a broad spectrum of the population, offering vaccines against Measles Rubella (MR), Oral Polio (OPV), and Pneumococcal diseases (PCV) to the young, alongside Vitamin A supplements and deworming tablets for children under five. Meanwhile, individuals over the age of 12 were encouraged to receive their COVID-19 vaccinations, ensuring comprehensive protection across all age groups.

Parallel to these efforts, UNFPA and WHO intensified their initiatives to raise awareness about the prevention, transmission, and treatment of HIV and other sexually transmitted infections. Their collaborative endeavors culminated in the observance of World AIDS Day on December 1, 2023, marking a pivotal moment in the nation's fight against HIV/AIDS. This was further bolstered by the successful piloting of Pre-Exposure Prophylaxis (PrEP) within the key population HIV Prevention program, exceeding its target by reaching 214 beneficiaries.

The year 2023 also saw the successful development and implementation of the 5-year National Strategic Plan by the National AIDS Institute (INCSIDA), with UNFPA's unwavering support. This strategic plan laid the groundwork for comprehensive HIV testing across the country, reaching an impressive milestone of 11,855 beneficiaries and surpassing the target set in collaboration with the Global Fund and the Ministry of Health.

Through these concerted efforts, Timor-Leste not only demonstrated its commitment to overcoming the immediate challenges posed by the pandemic but also showcased its dedication to the long-term health and well-being of its citizens. The integrated immunization campaign and the strides made in HIV/AIDS prevention and treatment exemplify the nation's resilience and proactive approach to public health, setting a precedent for future healthcare initiatives.

n 2023, Timor-Leste marked a pivotal year with significant strides in peacebuilding, gender equality, and human rights, with the collaborative efforts of the UN. On 31 July, the nation celebrated the launch of its first National Mediation Network, a milestone in enhancing national mediation capacity. This initiative, fostered by the cooperation between eight line ministries, one civil society organisation, and the National Directorate for Community Conflict Prevention within the Ministry of Interior, aimed to promote gender-responsive mediation and women's participation in peacebuilding. It aligns with the National Action Plan on UN Security Council Resolution 1325, emphasising the prevention of conflict escalation and the promotion of social cohesion. This work directly contributes to two critical national priorities - security and justice sector reforms. Timor has a dual justice system, the people, especially women, prefer the alternate dispute resolution mechanisms as they are easily accessible. The establishment of a mediation network will reduce the structural barriers that women face in accessing dispute resolution services, which will lead to an increase in 'women's leadership and participation in dispute resolution.

The Government of Timor-Leste does not fully meet the minimum standards for the elimination of trafficking but is making significant efforts to do so. The government demonstrated overall increasing efforts compared to the previous reporting period, considering the impact of the COVID-19 pandemic on its anti-trafficking capacity; therefore Timor-Leste was upgraded to Tier 2. To further strengthen government's efforts the Ministry of Interior, with UN support, established Community Mobiliser Networks (MCN) in four municipalities recognized for their susceptibility to human trafficking-Dili, Bobonaro, Covalima, and Oecusse. These networks focus on enhancing community awareness, improving responses to trafficking cases, and challenging the stigma faced by survivors, showcasing a united front against human trafficking and gender-based violence. The CMNs directly engaged with over 300 community members across the target municipalities, identified and trained women and men community leaders, first-line responders and national experts to increase knowledge and raise awareness about human trafficking and related forms of exploitation and GBV, mitigate stigmatisation of survivors and ensure increased capacity of the local communities to prevent and respond to human trafficking in a gender-responsive way.

The Secretariat of State for Vocational Training and Employment, alongside the Trade Union Confederation and Chamber of Commerce, took

a stand against workplace violence and harassment by developing a Pocket Guide, with a Bipartite Agreement signed in December 2023 to ensure its implementation. This initiative is part of a broader effort to create safer work environments across Timor-Leste.

Through the Spotlight Initiative, the UN reached out to 74,305 individuals, significantly improving access to and the quality of services for gender-based violence survivors. This was achieved by partnering with 21 civil society organisations, illustrating a nationwide commitment to supporting women and girls, with thousands gaining knowledge of essential GBV services and recovery services by the year's end.

The legal landscape saw advancements as well, with the enactment of the Protection of Children and Youth in Danger Law in 2023. This was complemented by a comprehensive capacity-building program that included the rollout of child protection laws, training for judicial actors, and the professionalisation of 125 social service workers. The operationalization of the Child Marker in state budgeting highlighted a significant shift towards prioritising children's wellbeing. The UN in partnership with the Ministry Of Finance supported the integration of the Child Marker in the Government budgetary system. The high-level advocacy efforts resulted in significantly increased government budget allocations for areas such as preschool (by 230 per cent) and nutrition (252 per cent).

The political arena witnessed a notable increase in female voter turnout in the 2023 Parliamentary Election, buoyed by the UN's efforts to strengthen 'women's leadership and participation in elections. This not only led to a 2.3% increase in female voter turnout but also the historic election of the first female President of the National Parliament, signalling a breakthrough in gender equality in governance. The total voter turnout for the 2023 Parliamentary Election was 705,638 (80.3%), disaggregated by women 343,268 (48.6%) and men 362,415 (51.4%).

In support of the Timor-Leste Parliamentary election, the UN supported the media to strengthen the National Fact-Checking Alliance, consisting of students, journalists, and academics. This included a series of trainings on fact-checking, pre-bunking and incorporating media literacy in the alliance's operations. The UN also enhanced the independence and capacity of the Timorese media to provide public interest reporting on climate change as well as to play an active role in disaster preparedness and risk reduction. This included capacity-building trainings, story grants as well as roundtable discussions between the Press Council, the media and the government (including the Ministry of Social Communications and the Civilian Protection Authority) on establishing protocols and escalation mechanisms for ensuring access to and release of critical information during crises.

The Municipal Finance Law, adopted in 2023 with UN support, alongside initiatives to build capacities

among municipal public servants and improve support mechanisms for GBV victims, underscored a commitment to strengthening local governance and enhancing legal and trauma-sensitive approaches for GBV victims.

In the health sector, the UN collaborated with the Ministry of Health to develop disability and gender-related indicators for the National HMIS Strategic Action Plan 2024-2030. This effort, aimed at improving data collection on violence against women and girls in the health sector, sets a new standard for health monitoring and evaluation in Timor-Leste.

Additionally, the reactivation of the "Women in Leadership and Diplomacy Forum" in September 2023, with support from the Ministry of Foreign Affairs and Cooperation, has created a vibrant network of over 90 national and international women leaders. This forum stands as a testament to the ongoing efforts to dismantle leadership barriers in governance and diplomacy.

In a significant milestone for the country, the law on the Protection of Children and Youth in Danger, which draws key elements from the Child Rights Convention (CRC), was passed by the National Parliament and promulgated by the President, showing a high level of political commitment to strengthen the child protection system. The law was widely consulted and developed with technical assistance from the UN. This was followed by a review of the standard operating procedures (SOP) for child protection. Other key legislations, such as the open regime regulation decree law for children in detention, SOP for birth registration, civil registration and vital statistics resolution and road map, also progressed to the final stages.



RG5 STORY:

"Doing more together: Giving life to springs through collective efforts."

The Success Story of Water Conservation in Oe-Cusse

n rural Oé-cusse, where water is a big issue for most of the communities, Maria believes that reforestation is the only means to conserve and give life to the spring.

Water scarcity issues in Oé-Cusse, exacerbated by climate change, severely affect rural livelihoods. In areas where water supply is limited, springs like Oelfisot and Oel Let Ana serve as an important lifeline for the surrounding communities. Over the past years, the dry climate, lack of water from these springs, and degradation of the surrounding environment, have probe serious short- and long-term problems for the villagers.

Maria Simão, a 66-year-old woman shared her struggle to access clean water. "I depend on the Oelfisot spring for my family's daily needs, but with the limited water debit of the spring, I struggle to secure enough water for cooking and drinking" she lamented. During the dry season, the water flow is reduced even further, leading to hours of waiting for just fill few jerricans of water. Maria had to fetch water three times a day spending about 6 hours in total on securing water. As they looked to the future. Maria and her community wondered how they could spare their children and themselves from the relentless quest for water.

Fortunately, both springs, the Oelfisot and Oel let Ana, once on the brink of depletion, have been regenerated thanks to the participation of local communities in UNDP's water conservation program. These efforts were concentrated in two distinct locations, encompassing the springs. With the implementation of innovative water catchment techniques, such as the construction of infiltration ponds and stone dams across the valley there was a substantial boost in the spring's water supply, bringing joy to the villagers. Maria excitedly shared "Now I can transport three jerrycans at once without the spring water debit becoming too low". She also explained how this newfound abundance allowed her and her community to utilize the water for a multitude of purposes, from cooking,

drinking, laundry, and crop and tree irrigation. "I even provide water for my chicken and goat" proudly beaming. This condition also teaches, trains communities to use water for really necessary.

Maria further described how the program made her realize that the current water problems were linked to deforestation, land clearing, and forest burning. With support from A-FFOS and UNDP, the communities also embarked on a successful regreening effort, visualized in the photo story below. The success of the Oel Let Ana and Oelfisot water conservation programs is a testimony of the power of collective effort, nature-based solutions, and the commitment to securing the spring, a vital source of water for generations to come.

imor-Leste has made remarkable strides in bolstering its readiness and response to emergencies in 2023. The UN led the charge by enhancing emergency coordination through detailed logistics assessments, broadened the nation's early warning capabilities with the rollout of Disaster AWARE Pro, ensuring that timely alerts reached every corner of the country. The UN took significant steps to shield 5,200 people from the impacts of agricultural drought by implementing its Anticipatory Action Protocol, complemented by a monitoring mechanism

that utilised the Combined Drought Index for early detection.

In a unique collaboration, the 'UN's through 'UN-ESCO's Intergovernmental Oceanographic Commission (IOC) and the Indonesian Meteorology, Climatology, and Geophysics Agency (BMKG) embarked on a mission to document firsthand accounts from over 30 witnesses and survivors of earthquakes and tsunamis in Flores sea, Indonesia in 1995. This invaluable historical data is set to enhance future preparedness efforts, ensuring that lessons from the past inform the strategies of tomorrow.



UN agencies worked in concert to fortify the disaster response framework of Timor-Leste, both at the national and community levels. The UN equipped officials with skills in multi-hazard mapping and drone usage, disaster risk management training programs reached an impressive 61,000 individuals, including contribution to logistics and supply chain management training enriched the capabilities of 382 government personnel, preparing them for swift action in times of need. Under UN's guidance, Timor-Leste saw the completion of 18 schemes of climate-resilient infrastructure projects, spanning rural roads, water systems, and more, alongside agroforestry interventions across 70 hectares in 24 villages. Guidelines and Standard Operating Procedures (SOPs) were developed to ensure the sustainability of these investments and disseminate best practices.

This initiative not only enhanced the nation's infrastructure but also supported environmental sustainability and cultural preservation. The UN has improved the access to renewable energy for 7.000 rural residents excluded from the formal grid, providing solar panel lights and water pumps to 1,000 households, meanwhile conducted environmental assessments and implemented nature-based solutions for water catchment management in certain regions and replant traditional Tais raw materials, like cotton trees. in targeted areas like in Oecusse to improve water resource management and reduce the risks of landslides and soil erosion.

The 'UN's collaboration with Indonesia on sustainable fisheries bore fruit with the finalisation of a Transboundary Diagnostic Analysis and the adoption of a Regional Strategic Action Plan. This partnership was instrumental in building the capacities of fishing communities for climate adaptation. Additionally, the 'UN's efforts in coastal and marine resource management culminated in the creation of a new Marine Protected Area, safeguarding 51,000 hectares of marine biodiversity.

Despite these achievements, challenges such as limited disaster risk management resources, coordination gaps, and sustainability concerns for solar power systems persist. Advocacy efforts continue to highlight the need for integrated climate adaptation measures, improved coordination, and dedicated government funding for disaster risk reduction and management.

Looking forward to 2024, the UN is set to deepen its commitment to Timor-Leste by focusing on enhancing the capacities of government staff and stakeholders in disaster management, completing key infrastructure projects, and supporting the implementation of the National Disaster Risk Management Strategy. These efforts aim to reinforce early warning systems, emergency response capabilities, and the management of coastal and marine resources, ensuring that Timor-Leste is better prepared to face the challenges of tomorrow.



RG6 STORY:

Resilience in the Green Hills: The Women of Balibar Rebuild Lives After Seroja

imor-Leste- Located in the east of Dili, the capital of Timor-Leste, Balibar is a village of rugged but stunning terrain. In 2021, many homes were severely damaged when Cyclone Seroja struck the country, and those in Balibar were no exception.

A mother of six, Katarina faced adversity headon when the cyclone-induced floods partially destructed her home and swept away personal possessions, depriving her family of everything they had. Back then, heavy rains, landslides and floods ravaged 12 municipalities and claimed 45 lives, leaving thousands in Timor-Leste without homes or livelihoods.

Despite the mobility challenges posed by her age (64) and health, along with the daunting task of finding employment, Katarina put her life and family back together through her farming business and by selling fruits and vegetables.

"It was incredibly challenging to rebuild my life from the ground up after the floods. Not just to slowly rebuild my home but regain what we lost. Through what I grow and sell in the markets, I am now able to support both myself and my family."

Like Katarina, Maria, a widow of three, lost her possessions to the floods, while her home was partially damaged. The aftermath of the floods left her in shock, making her wonder if she would ever recover from the loss.

Fortunately, Maria was able to quickly stand on her feet again. With the shelter repair kits and non-food items she received from the International Organization for Migration (IOM) in 2021, as part of the emergency response efforts, she rehabilitated her damaged home and pulled her family back together under one roof.

"The shelter repair kits have been very helpful. Since my house was rebuilt, I have been able to prepare for the floods from sweeping away my house. Nowadays, we are still very afraid of such emergencies, but I have learnt to stay strong and be a wall of protection for my children and grandchildren "Maria shared.

Through the trees, down a narrow path and multiple slopes, lives Senora Olinda, Balibar's eldest resident, who is around 100 years old. Having witnessed World War II, the independence of her country and various events throughout her years, her life is already a story of resilience and wisdom.

Choosing to live a life dedicated to family and service, Olinda has cared for her sister's children since they were born in the 1950s, planting the seed of strength and perseverance within the family.

In 2021, Olinda shared with IOM, "I woke up to Seroja early in the morning when it was still dark. Living alone, I was terrified my house would collapse or explode."

Olinda found shelter in her sister's house, and IOM supported her and the family to rebuild back then.

Three years on, Olinda says that she finds joy in her days now, tending to her livestock, and caring for her great-grandchildren. Occasionally, she immerses herself in gardening, planting and harvesting fresh products to prepare meals for the generations in her family as they come together in her home.

In Timor-Leste, climate change exacerbates the risks of disasters and environmental degradation. Working to enhance the resilience of affected communities and displaced populations, IOM is supporting people who want to stay in their home areas by increasing investments in disaster risk reduction measures and local adaptation through programmes on disaster risk reduction and protection.

2.3. SUPPORT TO PARTNERSHIPS AND FINANCING THE 2030 AGENDA

n January 12, 2023, Timor-Leste embarked on a groundbreaking journey to fortify its public health defences against the backdrop of the COVID-19 pandemic with the official launch of an integrated immunisation campaign. This initiative, a collaboration between WHO, UNICEF, and other key partners, epitomised a holistic approach to healthcare by amalgamating routine immunizations with COVID-19 vaccinations, and augmenting these efforts with deworming and vitamin A supplementation.

The essence of this campaign was to counter the disruptions experienced by routine health programs due to the pandemic. As COVID-19 spread, the continuity of essential immunisation activities was challenged, with healthcare workers often redeployed to pandemic response duties and parents increasingly wary of exposing their children to the virus at health facilities. Amid these challenges, Timor-Leste's health authorities recognized the critical need to rejuvenate their immunisation efforts, leading to the innovative integrated campaign that aimed to leave no one behind.


This ambitious campaign targeted a broad spectrum of the population, offering vaccines against Measles Rubella (MR), Oral Polio (OPV), and Pneumococcal diseases (PCV) to the young, alongside Vitamin A supplements and deworming tablets for children under five. Meanwhile, individuals over the age of 12 were encouraged to receive their COVID-19 vaccinations, ensuring comprehensive protection across all age groups.

Parallel to these efforts, UNFPA and WHO intensified their initiatives to raise awareness about the prevention, transmission, and treatment of HIV and other sexually transmitted infections. Their collaborative endeavours culminated in the observance of World AIDS Day on December 1, 2023, marking a pivotal moment in the nation's fight against HIV/AIDS. This was further bolstered by the successful piloting of Pre-Exposure Prophylaxis (PrEP) within the key population HIV Prevention program, exceeding its target by reaching 214 beneficiaries.

The year 2023 also saw the successful development and implementation of the 5-year National Strategic Plan by the National AIDS Institute (INCSIDA), with UNFPA's unwavering support. This strategic plan laid the groundwork for comprehensive HIV testing across the country, reaching an impressive milestone of 11,855 beneficiaries and surpassing the target set in collaboration with the Global Fund and the Ministry of Health.

Through these concerted efforts, Timor-Leste not only demonstrated its commitment to overcoming the immediate challenges posed by the pandemic but also showcased its dedication to the long-term health and well-being of its citizens. The integrated immunisation campaign and the strides made in HIV/AIDS prevention and treatment exemplify the nation's resilience and proactive approach to public health, setting a precedent for future healthcare initiatives.

2.4. RESULTS OF THE UN WORKING MORE AND BETTER TOGETHER: UN COHERENCE, EFFECTIVENESS AND EFFICIENCY

Programme Management Team (PMT)

In 2023, the UN Programme Management Team (PMT) was established in Timor-Leste, marking a pivotal advancement in executing the United Nations Sustainable Development Cooperation Framework (UNSDCF) for 2021-2025. Aimed at bolstering coordination, implementation, and oversight, the PMT ensured alignment with national priorities and the Sustainable Development Goals (SDGs), enhancing the UN's programmatic coherence, efficiency, and impact. Comprising Deputy Representatives or Senior Programme Staff of UN Agencies, the M&E Group focal point, and the Head of the Resident

'Coordinator's Office (RCO), the PMT facilitated diverse and comprehensive program management, leveraging a broad spectrum of expertise. It played a crucial role in guiding program coordination, offering technical support, ensuring effective linkages between strategic priorities, and spearheading the UNSDCF evaluation process. Additionally, the PMT's efforts in finalising its Terms of Reference (TOR) and revising the Monitoring & Evaluation Working Group (M&E WG) to function as a subgroup, including finalising CCA update, highlighted its commitment to accountability and continuous improvement.

Monitoring & Evaluation (M&E) Working Group

In 2023, the Monitoring and Evaluation (M&E) group held two regular meetings prior to the Results Groups (RGs) meetings to collaboratively understand their responsibilities. Consequently, the M&E group, via its RG focal point, facilitated the RGs' 2023 annual review and the planning for 2024. Four members of the M&E participated in Cooperation Framework Evaluation training in Bangkok and were involved in the ongoing evaluation process as the Evaluation Technical Management Team, which commenced in the fourth

quarter of 2023. The M&E group also contributed to the first Common Country Analysis (CCA) update since its last iteration in 2020. Moreover, the M&E group assisted the RGs in providing inputs for the inaugural UNSDCF annual One UN Country Results Report. With the M&E group's assistance, the 2023 Information Management System (IMS) and UN Department of Economic and Social Affairs (DESA) surveys were completed and submitte

Operations Management Team (OMT)

The UN in Timor-Leste shared the common Premises whereby efficiency via economies of scale was critical. The OMT of Timor-Leste supported the harmonisation of Common Premises long-term agreements (LTAs), resulting in three new and one renewed LTA s on security service, cleaning and gardening service, pest control service, building and maintenance service, waste

and liquid collection and One Internet solution. Harmonising common LTAs resulted in efficiency gains for UN agencies, forming part of the Business Operations Strategy (BOS), in which 14 UN agencies participated. Through the consolidated efforts supported by OMT, the UNCT Timor-Leste became one of the first countries in the region to complete and sign the BOS initiative.

United Nations Communications Group (UNCG)

The United Nations Timor-Leste Communications Group, supported by the Resident Coordinator's Office and as part of the UN System Reform, has significantly boosted the UN's influence and visibility in Timor-Leste through a unified and strategic communications. By adopting the "Communicating as One" approach, the group has successfully aligned its messages and policies with national priorities, the UNSDCF, and Agenda 2030, enhancing the UN's outreach and cohesive voice across the country.

This strategic communication has effectively highlighted the UN's contributions in areas like Food and Nutrition, Economic Development, Education, Health, Governance, and Disaster Resilience. Major events, UN days, SDG Summit, SDG

Act Now Campaign, and initiatives such as the 2nd National Voluntary Review of SDGs, the 2023 Parliamentary Elections, Timor-Leste's steps towards ASEAN and WTO membership, transitioning to solar power, and the Census 2023, have all benefited from this focused approach.

The Government's recognition of the UN's efforts underlines the success of this strategy in strengthening the UN's role and story in Timor-Leste, demonstrating the power of unified communications in supporting the country's development goals. This approach not only amplifies the UN's impact on crucial issues but also solidifies its standing as a key partner in Timor-Leste's journey towards sustainable development.

Leave No One Behind Human Rights

In 2023, the UN in Timor-Leste navigated through a challenging landscape marked by presidential elections, which momentarily slowed program momentum due to the political focus in the first half of the year. However, it adeptly shifted its strategy to prioritise election-related activities, achieving notable success in monitoring human rights issues during the electoral period, providing essential support and analysis on political and human rights risks, and enhancing the capacity of the National Human Rights Institution (NHRI) and civil society organisations in addressing human rights concerns tied to elections.

As the year progressed and political tensions subsided with the election of a new President, the UN witnessed a significant improvement in program implementation. It resumed and effectively executed its capacity-building initiatives for police and military personnel, in collaboration with NHRI, the National Police Academy, and the Ministry of Defense, delivering nine intensive one-week training sessions. This effort has been widely recognized for its impactful role in preventing human rights violations, garnering acclaim from government, civil society, and the beneficiaries themselves.

The UN has also played a pivotal role in strengthening civic engagement and collaboration in Timor-Leste. Its steadfast support and technical advice to the Office of the Provedor for Human Rights and Justice (PDHJ) throughout various challenges have solidified its position as a key ally and advisor. Moreover, its efforts to foster dialogue between the PDHJ and civil society organisations have facilitated meaningful exchanges on pressing human rights issues, through guarterly meetings that have been instrumental in bringing civil society concerns and recommendations to the forefront.

Expanding its focus to encompass economic, social, and cultural rights, UN has courageously tackled issues affecting vulnerable groups, notably advocating for the cessation of bullying and harassment against LGBTIQ students to ensure their right to education. This initiative addresses the critical challenge of violence and discrimination that leads to high dropout rates among LGBTIQ students in schools and universities. Additionally, the UN has ventured into advocating for social protection access for women in the informal sector, a significant portion of Timor-Leste's workforce, marking a strategic expansion into new areas of work and partnership.



Gender Equality and 'Women's Empowerment

In 2023, the Gender Thematic Group in Timor-Leste implemented a multidisciplinary strategy to address gender-based violence (GBV), aiming to challenge and change the deep-seated societal norms around gender roles. This effort aligned with one of the strategic pillars of the National Action Plan on GBV (2022-2032), which focuses on preventing violence against women and girls at educational institutions, within communities, and beyond.

Under this framework, the Ministry of Education and the Ministry of Youth, Sports, Arts, and Culture launched projects in collaboration with UNFPA and local civil society organisations, including Belun, Hamutuk Nasaun Saudavel (HAMNASA), Alola Foundation, and FOKUPERS. These initiatives were part of the ZONTA phase 1, Spotlight Initiative, and Together for Equality projects. They aimed to deliver comprehensive sexuality and reproductive health education in youth centres and schools to foster gender-equitable attitudes and equality in intimate relationships, while also raising awareness of GBV's health impacts and the available support services.

Throughout the year, these programs successfully reached nearly 2,400 women and girls across Dili, Baucau, Viqueque, Ermera, Bobonaro, Covalima municipalities, and the SAR of Oecussi-Ambeno. Participants gained enhanced knowledge on maintaining healthy relationships, understanding GBV and sexual and reproductive health (SRH), preventing early pregnancy, recognizing the dangers of unhealthy relationships, managing anger, and financial literacy.

Additionally, approximately 2,300 women community leaders and members enhanced their understanding of gender, gender equality, and a human-rights-based approach to gender equality. They learned about GBV, its health impacts, prevention strategies, SRH rights, and the availability of support services. The collaborative efforts of the health, police, justice, and social service sectors played a crucial role in spreading information on multi-sectoral prevention strategies, GBV referral pathways, and case management systems. This comprehensive approach ensured a robust multi-sectoral response to GBV, offering continued care and protection for women and girls experiencing violence.

Youth Empowerment

In 2023, the UN Youth Results Group (YRG), comprising 11 UN agencies, took significant strides in supporting the National Youth Action Plan approved by the Timorese Government. This collaborative effort centred around the strategic pillars of education, employability, employment, entrepreneurship, ecosystem, and engagement collectively known as the six E's- to catalyse a generational shift for the youth of Timor-Leste.

Recognizing the imperative for a more cohesive approach among UN agencies, government ministries, development partners, and civil society for youth empowerment, the Vice Prime Minister and Coordinating Minister for Social Affairs initiated an Inter-Ministerial Task Force on Social Affairs in September 2023. This task force, with youth empowerment as one of its key focus areas, has seen committed support from UN agencies aiming for an integrated stakeholder engagement strategy.

The Youth Results Group, with active participation from all the 11 agencies, has successfully positioned youth empowerment at the forefront of the Vice Prime Minister for Coordination of Social Affairs' agenda. UN's engagement in comprehensive sexuality education (CSE) both

in and out of school settings, along with youth empowerment and employment initiatives, has marked a pivotal contribution to this cause.

The Ministry of Education's approval of CSE implementation in over 47 schools has reached nearly 3,900 adolescents and youth nationwide. Additionally, the Boys and Girls Circle module has been disseminated to 1,400 individuals, fostering a supportive environment for comprehensive youth development. Furthermore, the Comoro Child and Youth Center (CCYC) has seen the review and enhancement of its learning content, with 133 modules across five subjects refined into 160 hours of training content, thereby enriching the educational resources available to young people.

With UN's support, the Ministry of Youth, Sports, Art, and Culture launched the "Kolega" ChatBot, a digital platform designed for youth. This innovative tool facilitates job and training program applications, provides access to learning tools, and connects users to various learning platforms. Within a month of its launch, more than 500 youths had registered on the platform, underscoring the digital solution's immediate impact and reach among Timor-Leste's youth population.



Persons with Disabilities

In 2023, the UN significantly advanced the rights of people with disabilities in Timor-Leste, advocating for their inclusion and supporting Disabled Peoples' Organizations (DPOs) in pushing for the country's accession to the Convention on the Rights of Persons with Disabilities (CRPD). This advocacy was crucial as Timor-Leste underwent its third Universal Periodic Review, highlighting the need to join the CRPD. Despite initial governmental hesitance, citing the need for a National Council for Persons with Disabilities as a prerequisite, persistent efforts led to the approval of a draft resolution on 4 May 2023 for Timor-Leste's state party status to the CRPD and its Optional Protocol, a process later completed with UN Secretary-General formal ratification in progress.

Moreover, the UN's role extended to offering technical advice for finalising the ratification

process, resulting in Timor-Leste acceding to the CRPD on 17 January and its Optional Protocol on 7 February 2023, marking a historic commitment to disability rights among 187 countries. Additionally, the 2022 Housing and Population Census, enhanced by the inclusion of Washington Group questions, aimed to provide more accurate data on people with disabilities, addressing their underrepresentation in previous data. The UN also facilitated a meeting with various stakeholders, including the Ministry of Justice, state representatives, and civil society organisations, to discuss implementing recommendations from human rights mechanisms on disability rights, further demonstrating a comprehensive approach to improving the lives of people with disabilities in Timor-Leste.

Disability Empowerment: Chasing Dreams of a Better Future

Consultations in Ermera have mobilised the engagement of youth with disabilities to determine their own future

Ermera, 13th August 2023 - Leonito de Deus was born a healthy little boy until the age of 2, when his life would change forever. After falling ill from an unknown disease, Leonito started to develop a physical impairment that impacts his spine and his ability to walk. Now 13 years old, Leonito has fought hard every day to receive an education and sense of fulfilment in life. From grade 1 until grade 3 Leonito walked on his hands for miles to reach school in his home village of Letefoho. This impressive feat left him dirty, exhausted, and unable to focus on his studies. With very little energy to stay motivated, Leonito stopped going to school.

Joanico from Ra'es Hadomi Timor Oan (RHTO) an organisation for people with disabilities, reached out to Leonito's parents and convinced them to let him stay in Gleno with Leonito's uncle, so that he can receive assistance from the organisation to help him get back to school. Since moving, Leonito has received a wheelchair and found a vibrant community at his school that treats him with respect and kindness.



"I like to play with my friends. They come to play with me at the front of my house, we really love football."

It is clear that improved access to his school and community has made a tangible impact on his life and his ability to participate however, there is still a lot of work to do to increase access and participation for youths with disabilities in Timor-Leste. Evidence suggests violence and abuse of people with disabilities is still common and key infrastructures lack accessibility measures. While Leonito's participation in school has increased, there are still key access challenges that he is facing.

"I can't operate my wheelchair on my own because it's too big, so I need my family to take me to school. If no one is home, I still have to walk on my hands for 2 kilometres to get to where I want to go."

There are also no ramps at Leonito's home, so he must climb down his porch, through the dirt and over rocks to get to the road. Lack of safe footpaths and ramps in the community make Leonito's commute to school dangerous and inaccessible. The lack of accessible infrastructure at school is another challenge to navigate, as friends and teachers help Leonito to get into the classroom. Establishing a clear guideline on how to better provide access to participation for youths with disabilities is a pivotal move that has the chance to provide lasting impact on the lives of so many.

In July 2022, UNICEF in Timor-Leste, with support from the Australian Government through the Australian NGO Cooperation Program (ANCP), facilitated key consultations in several areas including Ermera, to create a space for youths with disabilities to have their voices prioritised. Recommendations from Leonito and 73 other youths with disabilities have formed a key document called 'Operational Guidance for the Rights to Participation of Adolescents and Youth with Disabilities in Timor-Leste'.

To date, 208 copies of this document have been disseminated across civil society organisations, government, and communities across the nation. UNICEF is leading the way in ensuring all stakeholders understand children's needs when it comes to access, so that participation is a key focus in all programs moving forward.

"I am very happy to see my contributions in this document. I hope that it can be used by the government and other organisations to increase participation for people with disabilities. My dream is to be a director of a disability organisation. I want to help support people with disabilities so they can have a life as good as abled people."

Leonito's big dreams are echoed by Esperansa Marcal dos Santos, a young 26-year-old woman who proudly participated in this consultation.



"My dream is to run my own organisation with my friends who also have disabilities. I want to make sure people have access to information. support, and services."

Much like Leonito, Esperansa was not born with her disability. It was not until she became ill at 10 years old that her family took her to the hospital in Dili. After one week in hospital, she was discharged and told to rest at home. One week later her body started to change, and her physical impairment started to form. The sudden change was confusing for Esperansa and left her devastated, trying to grapple with her new life. However, a lifetime of commitment to receiving an education has seen her celebrate the success of completing high school in 2021. Since graduating, Esperansa helps her mother at home with her siblings however, she wants more opportunities for meaningful participation in consultations and trainings. Due to her physical condition, Esperansa cannot walk very far, much less to training opportunities. There is a strong demand for accessible transport options to increase participation in the community.

"I hope that the government and development partners can follow these practical guidelines so everyone can have meaningful participation in the current activities. If these guidelines are not followed, participation is hindered. People need to think about our needs based on our disability."

Hearing these inspiring stories of local heroes fighting for their right to participation and access, one thing becomes very clear: empowering youth with disabilities to work in leadership positions in disability organisations, to create their own organisations, or to have the right to participate in the workforce, not just empowers youth with disabilities to lead self-determined, fulfilling lives but it paves the way for a more inclusive future. Allowing youth to make decisions on what impacts them is the most sustainable and dignified future to build, and all of this starts with access and participation.



2.5. EVALUATIONS AND LESSONS LEARNED

imor-Leste embarked on a pivotal journey to evaluate its first UN Sustainable Development Country Framework 2021-2025, positioning itself as one of the four pioneering countries in the Asia Pacific region to undertake such a comprehensive review. This initiative was preceded by a meticulously organized planning phase in 2023, marked by significant preparatory steps and robust stakeholder engagement, underscoring a collective commitment to enhancing development effectiveness.

The evaluation's groundwork was laid with an official notification by the Resident Coordinator to the UN Country Team/Result Groups, the Development Coordination Office, and the apex national counterparts, ensuring alignment and readiness among all stakeholders. Following this, the Evaluation Manager, who also chairs the Project Management Team, was appointed

alongside the formation of an Evaluation Technical Management Team, composed of four Monitoring and Evaluation group members. This strategic assembly of expertise and leadership was pivotal in steering the evaluation process.

Further solidifying the evaluative framework, a National Evaluation Steering Committee was established, incorporating members from the Country Framework Joint Steering Committee. This step fostered an inclusive and collaborative environment for the evaluation's execution. Additionally, the preparation of a comprehensive Terms of Reference delineated the evaluation's objectives, scope, and methodology, serving as a foundational guide for all activities. This phase of high engagement and strategic planning culminated in a strong platform for the subsequent selection of a consultant and the execution of the evaluation process in 2024.

2.6. FINANCIAL OVERVIEW AND **RESOURCE MOBILISATION**

n 2023, the UN had a required budget of US\$82.8 million and of this amount US\$ 50.8 million was obtained, leaving the funding gap of US\$ 32 million for the UNSDCF implementation in Timor-Leste. The UN was able to spend a total of US\$ 40.3 million, resulting in an overall delivery rate for all the UNSDCF Strategic Priorities (SPs) is approximately 80%. This rate indicates the efficiency with which the available resources have been expended towards achieving the strategic priorities across the board and reflects a relatively high level of resource utilisation in the execution of the outlined strategic priorities.

The Delivery Rate across the strategic priorities varies, indicating how efficiently the available resources are utilised. SP4 & SP5 shows high delivery above 90%, with SP4 showing the highest delivery rate at approximately 94%, followed by SP5 with 91%. These demonstrate a high level of resource utilisation towards the expenditures.

SP4 has the highest discrepancy between the total required and available resources, highlighting a significant area for potential increased funding and attention.
